1. Call to Order; Roll call by sign in: (quorum: Members = 20, Council = 7)

**Meeting called to order at 6:42 p.m. by Gordon Hall, EVP. Quorum declared present. Roll call by sign-in; attached.**

2. Appointment of Parliamentarian; AGENDA, review and approval:

**Bob Mayhew appointed as meeting Parliamentarian. Connie Mayhew appointed as meeting secretary. Two items (with \*'s) added to end of agenda.**

3. MINUTES (Jan 2015 meeting), review and approval:

**Motion to approve by Mark Chambers; second by Kerri Lee. Discussion, Jeran Hooten does not agree with the wording of part of the minutes. Motion passes 12-2.**

4. Treasurers Report: - Kathy Ives; HEAD TAX!!

**As-of now, we have \$29,400 in our bank account. After all outstanding checks clear, the book balance is \$26,965. No major changes to our financial position. **Many thanks to the folks at Princeton Lakes for another outstanding JD clinic, tournament and banquet.**

2. Site selection for 2016?

**No bids presently; motion by Kathy Ives, second by Bob Mayhew, to extend deadline and site selection until Midwinter meeting in Jan. 2016.**

3. New JD Committee Chair

**Council resolution to applaud Scott Greenwood for his service on the JD committee over the past 14 years. Scott will be stepping down as committee chair after Regionals, and replaced by Jennifer Parker. Council welcomes Jennifer and offers support and encouragement.**



7. Membership issues: (all senior members are eligible to vote on the following)

**Meeting turned over to Elgin Faulkner to preside over this item #7, as Chair of Tellers Committee.**

1. Election of EVP (1 year term); **Gordon Hall re-elected for another term, by acclamation (motion: Elgin, second Bob M);**
2. Election of Director (3 year term); **Julie Krueger re-elected for another term, by acclamation (motion: Bob M, second Janet Hooten)**
3. Election of Alternate Director (3 year term); **Bob Mayhew elected as alternate director (motion: Elgin, second Julie K)**
4. Regional Tournament site selection for 2015. **No bids submitted. Motion (Julie, second Mark Chambers) to defer until November, and direct the EVP to work on finding a suitable host. This needs to be known prior to putting together next year's tournament schedule at the local level. Motion carries.**

8. Council Issues (Only council members are eligible to vote on the following)

1. Certify elections of EVP and Directors. **Passed 10-0**
2. Elect (re-elect) Vice-EVP and Treasurer. **Re-elected Jerry Bautsch and Kathy Ives as Vice-EVP and Treasurer, respectively. Motion: Bob Mayhew, second Michael Arora. Passed 10-0**
3. 2016 SCR Midwinter meeting: **See discussion and action under New Business, below**
4. Renew grants to Webmaster, Seeding Chair and Treasurer. **The grants are \$300 each, per year. Melissa Huitt is Seeding Chair; Kathy Ives is Treasurer. We presently do not have a Webmaster, Gordon and Kathy are doing it, and the \$300 grant for that has not been paid, and will not be paid unless a webmaster is found. Motion to approve (Julie K/Bob M); passes unanimously.**

9. Other business, old and new:

1. Requirements and deadlines for posting tournament announcements to web

**Motion by Gordon to require all tournaments approved at the Mid-winter meeting to be entered into the USA-WS sanctioning system by March 1. Any missing details or info not yet known will be put as "TBA". This way the online calendar will at least show the date and location, and serve as a place-holder. Motion approved.**

2. State tournament weekend

**Reminder to everyone that council voted at the mid-winter meeting to dedicate one weekend for holding state championship tournaments. this is a regional qualifying tournament (along with the JD tournament). Discussion of which weekend should be dedicated; suggestion that it be held as close to Regionals as possible, and not on July 4.**

3. Texas State Championships – bid, rotate location?

**Floyd McCreight presented the results of a survey (see attached) which showed 77% favored rotating the tournament among other clubs.**

**Motion by Gordon: Rotate the Texas State Championship tournament each year among the areas of Central, North and South Texas. Discussion of who would be determine the rotation order and club selection. Motion withdrawn by Gordon. Motion to table until next meeting by Jeran Hooten. Discussion. Motion to table passes 13 – 9.**

4. Regional Recommendations to AWSA Bd. of Directors Mtg.

**Get these to Gordon or Julie whenever you can, but prior to the AWSA board meeting at Nationals. Make your voice heard; this is how changes to the organization get made.**

5. \* **Go-To-Meeting at Mid-winter meeting:**

# 10 Point Strategic Plan

This is my plan that focuses on all areas of the sport that need help. You'll notice 7 of the 10 plans have nothing to do with the top 1% of our sport, which is something we have fell victim to concentrating on over the years and thus lost focus on the bottom of the pyramid.

These are in no particular order

**1-BETTER MEMBERSHIP PACKAGE-(brings in new members, retains current members)** we need a package that is more of a "want" than the current "need" our membership seems to be. Going after all the non-competitive skiers on the river or backyards that simply enjoy the sport and may never compete. Ideas are more epidemic discounts and coupons. Right now our membership is a competitive membership so once skiers don't compete they have no need for us. Bass fishing and hunting have done a great job at this; millions of members but only a small percentage competes.

**2-BETTER MARKETING OF USA WATER SK-(brings in new members)** Once we have a better package in place, we must find a way to market and sell it, we have to find the funds and plan to truly go after members and get in their faces and market to them to join USAwaterski.

**3-THE MINI COURSE-(gives beginner skiers a start to competition)** -the mini course has doubled membership in Australia. I would like to see every slalom course in America have a mini course. Work with Bart's or skier to skier to give 6 buoys and 6 sub floats at cost. Maybe AWSA kicks back something to USA Water Ski clubs who install these. Let's face it the course is hard; many struggle with it and do not enjoy it. NCWSA is a perfect example of where the mini course could have saved more members. What all the college kids did after barely getting to 2 ball for years was hop on jumpers. Now none of them are learning the skills to slalom and thus will never be buying slalom skis, boats, and staying in AWSA.

**4-OPEN SKI NIGHTS-(increase access to our sport)**-We need to find a way that the current 380 AWSA ski clubs open their doors to the public, we must sacrifice a few nights a month to give these skiers time on the water and lessons on skiing. We have all gone to closed private lakes but have shut the door on growth by doing so; we must sacrifice and open our doors, even if just for one night. I hope to get more grassroots events, more basic skills events, I'm hoping every single sanction this year has a grassroots sanction attached and offers a novice division.

**5-SKIING FOR PLACEMENT NOT SCORE-(Hits the semi competitive and competitive skier)**-We need to get away from being 100% worried about performances/rankings and focus more on placement and competition. This performance format has driven us to insane technology and cost and taken the fun out of the sport. Here is where a new rankings list

based on points, who you beat, participation, wins, etc., can change competitive skiing going forward. Our tournaments have become boring b/c they have too many divisions and no competition, there is no fun to drive 2 hours to just get a score, yes it works for those chasing scores but most are not, most want to compete, have fun, trash talk, this is when the sport gains ROI and when other obligations and expense win over choosing AWSA.

**6-REGIONALS/NATIONALS – (Competitive skier)**-Regionals and Nationals needs attention. The #1 complaint in surveys for skiers not attending nationals was time, expense, and lack of ROI on these events. Families simply cannot afford both events anymore unless those are going to be worth the time and money.

**7-ABILITY BASED DIVISIONS-(This covers beginners through elite)**-it may be time for our sport to follow all

other sports and combine age and ability so that tournaments are more competitive and fun. These ties strongly with #5 above but I made it a separate plan. This plan could include handicapped skiing as well. It goes back to the point that the sport has too few athletes to have 32 divisions. Plus take any new skier who just learned the course who may want to come ski an event, let's say they are in men's 3, guess who they get to ski against....39 off. That's the division AWSA has put them in. We need to think about ability based divisions especially at the lower level. One of the greatest parts of alumni regionals was seeing skiers in mens 1,2,3, 4 in the same divisions and all within 5 feet of each other. Would you rather watch that or watch 5 guys in the same division 60 feet apart but they ski against each other just b/c they are the same age.

**8-TEAM SKIING-(Covers beginners through elite)**-This is the ultimate form of fun in waterskiing. NCWSA...enough said. Alumni events last year had a 18% increase in membership in NCWSA. We have 2 things in the works for this, 1 is a proposal to the board. We hope to have team skiing at Regionals/Nationals next year. The other team concept Mark Crone is developing as a part of rankings where skiers will be able to form teams online and compete virtually. Team leagues such as mother/son, father/daughter, families, siblings; AARP, etc. will all be available to join. This should be active for this coming season.

**9. OFFICIALS PROGRAMS**-We must stop the bleeding, we are downgrading 1287 officials this year. Judges and Scorers committee is working very hard on this though. We are close to having CE for officials to take credits online. Melanie and HQ have really advanced the system at HQ for maintaining officials and giving more access and notifications to officials. This is by far the most time consuming and expense of HQ work each day.

**10. PROMOTE ELITE ATHLETES AND PRO SKIING**-We need to get pro skiing back on the map. We need our pros at nationals. We need our younger athletes looking up to them and aspiring to be a pro water skier.

# AWSA Presidents Report

**-State of AWSA address-**My first goal as President was to spend my first 6 months doing extensive research so that I knew exactly how to go about devising a strategic plan that would truly (hopefully) work. This was done via surveys to junior skiers, current members, and ex members, as well as all of you here in this room. I also spent dozens of hours with HQ, learning the ins and outs of their operation and assessing how they are doing and how we can work together to turn this thing around. At this point I'm happy with where I am in that process. I will admit that the thousands of ideas that came in at first were overwhelming and I was contemplating how we would settle on some direction, but one thing I noticed over time was that there were very common underlying themes in everyone's complaints and most led back to the same stuff. So below I have a 10 point strategic plan for the future of AWSA that I hoping covers most of the areas, your feedback on it is welcome.

So I'm done researching, it is time to start implementing and see what happens. There is no doubt we have our hands full in our quest to stop membership decline and bring in new members, but I'm confident we can do it. There are many things I learned in the surveys that we simply cannot fix, we are a tough sport, it's expensive and time consuming and this is a theme that is tough to fix and will always be a hinderance in a society these days that does not have time anymore and wants instant results. We are not the only one in this boat, snow ski racing is down 80%, golf courses are closing left and right; all NGB's are hurting so before we blame anyone for our decline we must accept that this is a worldwide epidemic. That being said there are 9 million water-skiers in the country, so we have plenty of customers that can make us a big organization.

**Surveys-Junior skier-**297 out of 1800 filled it out. 27% of juniors are starting school the week of or before Nationals. (FYI rule proposal to open up first week of August for Nationals). Survey responses were not good on separate nationals for JR and Sr. It was also not good on a Labor Day nationals. Including parents of the 297 surveyed about 83 people did not attend nationals due to school. The #1 answer for reason not attending was a tie between "It's not worth the time and expense. But I would attend if that changed". And "too expensive"

**Survey-AWSA Current members-**filled out by 1582 out of 5500. 28% of our members did not ski 1 event in 2015, 37% skied 5 or more. Of the 28% that did not compete 58% do ski for fun. #1 response to why they don't compete was "not good enough to compete", followed by "other obligations" and then "tournaments are not fun". For those that skied a few tournaments the #1 answer as to why they don't ski more is "other obligations". When asked what formats they would like to see it was all over, but the leaders where 29% said ability based skiing, #2 team skiing, #3 don't change anything, #4 handicapping. When asked what changes they'd like to see with reg/nat 27% said leave it and 27% said let people skip regionals. 68% of surveyors joined AWSA to compete. #1 complaint of reasons for not attending nationals was expense and time of attending regionals and nationals.

**Survey-Ex Members-**The response was very low on this survey and this was the one survey I was hoping to learn the most from. 526 out of 9000 filled it out. #1 reason for no longer competing was; 42% other obligations, 33% too expensive, 31% not fun anymore. 86% of the X-members still ski!!!!!!!!!!!!!!!!!!!!!! 33% said they would like to get back into it again and 35% said maybe.

**Survey-Board Members on Reg/Nat-**65 board/council members filled out a quick 4 questions survey on reg/nat, there was no general direction as expected, #1 answer were to leave nationals the same size, and leave qualifications the same way.

**-Nationals Contract** has been signed for 2016 Idaho; only change this year is the LOC will be designing and providing the medals so look forward to a change in medals. Idaho is going to put on a great nationals.

**-No bids for 2017 Nationals.** Bell Aqua sounded interested but it now looks like it will not happen. I have very little interest. I surveyed all 2-3-4 lake site owners in the country. The theme remains the same. Most lakes do not have a big enough core group of workers to pull off such a big event. Not sure where we go from here if we want nationals to be 700 plus skiers. We will just have to hope people step up but it does not look promising. I did get a lot of lakes tell me they would be happy to rent AWSA the lakes. Interesting concept that would make us more money but I cannot fathom how any outside group would come in and run such a detailed event, not without hiring an event group which would eat up all the profits but at least we would have a nationals. Interesting concept to ponder for now.

**-AWSA Branding-**Working on a new logo, trying to get Facebook and social media going for AWSA, so far since sept 2015 we are up 18% in likes. But there is much more we can do.
